- Include three to five 4x6" color photos of completed quilt (one full-view photo and up to four detail photos) marked with entrant's name/address/telephone, quilt name, and quilt dimensions. Photos will not be returned.

ABOUT THE CONTEST

On February 2, 1913, Grand Central Terminal opened in New York City after 10 years of construction. It was the first-ever double-level terminal for electric trains. In 1947, more than 65 million people traveled the rails via Grand Central. However, the rise of automobile travel in the 1950s meant a decline in rail travel, and by the 1960s, it appeared as though a wrecking ball might be the structure's fate. After a lengthy court battle the terminal not only was spared, but in 1976 also was put on the National Register of Historic Places.

Today, under the auspices of the Metropolitan Transportation Authority, Grand Central is Manhattan's best-known transportation hub and destination. With an average of nearly half a million visitors traveling through it daily, it is again a grand space worthy of its historic designation.

To celebrate the 100th anniversary of Grand Central Terminal, American Patchwork & Quilting® magazine and The City Quilter shop in New York City invite you to enter the Grand Central Terminal Centennial Quilt Challenge. The challenge is to design and produce an original quilt incorporating at least one of four designated fabrics

commemorating the terminal's 100th anniversary. Quilts selected as finalists and winners will be displayed at the New York Transit Museum Gallery Annex and Store at Grand Central Terminal.

Prizes:

Grand Prize: \$2,000

First Prize: \$250 City Quilter gift certificate

Second Prize: \$100 City Quilter gift certificate

Honorable Mention Prizes: A "City Bundle" of six fat quarters of New York-theme fabric and *Complete Guide to Quilting*®, Second Edition.

GRAND CENTRAL TERMINAL Centennial Quilt Challenge Contest Official Rules

Void outside the 50 United States, District of Columbia and where prohibited. Do not proceed to enter if you are not at least 18 years of age and a legal resident of, and located within, one of the 50 United States, or the District of Columbia, at the time of entry. By participating, you agree to be bound by these Official Rules and the decisions of the Sponsor, which are binding and final in all matters relating to this contest.

CONTEST PERIOD: The Grand Central Terminal Centennial Quilt Challenge Contest ("Contest") begins at 12:01 a.m. Central Time ("C.T.") on April 1, 2013 and ends at 11:59 p.m. C.T. on August 21, 2013 ("Contest Period").

SPONSOR: Meredith Corporation, 1716 Locust St., Des Moines, Iowa ("Sponsor").

HOW TO ENTER: During the Contest Period, follow the directions below to submit your entry:

- Create an original quilt that meets the following requirements: 1) Maximum quilt size 36" x 36" and 2) Minimum of 25% of the finished quilt top surface area must consist of fabrics designed and produced by The City Quilter of the "Grand Central" and "GCT Constellations" fabrics (order fabrics at www.CityQuilter.com or 212-807-0390 ("Quilt"). Sponsor and The City Quilter are not responsible for the availability of qualifying fabrics. Qualifying fabrics are available while supplies last.
- Visit www.AllPeopleQuilt.com or www.CityQuilter.com to download, print and complete the entry form. All fields must be completed to be eligible. You will also be given the option to receive a free fat quarter of one of The City Quilter's New York-themed fabrics. You may also request an entry form by sending a self-addressed stamped envelope to American Patchwork & Quilting, Grand Central Terminal Quilt Challenge Contest, Attn: Entry Form & Official Rules Request, 1716 Locust St., LN-204, Des Moines, IA 50309-3023.
- Include three (3) to five (5) color photographs (at least 4" x 6") of the completed quilt. Photos must consist of one (1) full view photo and up to additional four (4) photos showing details. Each photo must be marked with the entrant's name/address/telephone, quilt name, and quilt dimensions. Photos will not be returned.
- A 100–150 word written explanation of how the Grand Central Terminal centennial theme was interpreted within the quilt design.
- All persons involved in making the quilt must be listed in an attachment to the entry form.
- If two (2) or more people are involved in making the quilt, the person listed on the entry form will be deemed the contact person for the applicable entry and in the event that the entry is awarded a prize, prize will be awarded in such entrant's name.

- Send entry form, photos and written explanation to American Patchwork & Quilting, Grand Central Terminal Quilt Challenge Contest, 1716 Locust St., LN-204, Des Moines, IA 50309-3023.

Photos, written statement and entry form shall collectively be referred to as an "Entry". All Entries are final upon submission and must be postmarked by August 21, 2013 and received by Sponsor by August 28, 2013 to be eligible.

Entry may not contain, as determined by the Sponsor, in its sole discretion, any content that:

- is sexually explicit or suggestive; unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group; profane or pornographic; contains nudity;
- promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promotes any activities that may appear unsafe or dangerous; promotes any particular political agenda or message;
- is obscene or offensive; endorses any form of hate or hate group;
- appears to duplicate any other submitted Entries; contains trademarks, logos, or trade dress (such as distinctive packaging or building exteriors/interiors with the exception of the qualifying Grand Central fabric) owned by others, without permission;
- contains copyrighted materials owned by others (including photographs, paintings or reproductions, and other works of art or images published on or in websites, television, movies or other media), without permission;
- contains materials embodying the names, likenesses, or other indicia identifying any person, including, without limitation, celebrities and/or other public or private figures, living or dead, without permission;
- contains look-alikes of celebrities or other public or private figures, living or dead;
- communicates messages or images inconsistent with the positive images and/or good will to which Sponsor wishes to associate; and/or
- violates any law.

Entry must be the original work of the entrant(s) named on the entry form (including any attachment attached thereto), may not have been previously published, may not have won previous awards, and must not infringe upon the copyrights, trademarks, rights of privacy, publicity or other intellectual property or other rights of any person or entity. If the Entry contains any material or elements that are not owned by the entrant(s), and/or which are subject to the rights of third parties, the entrant(s) is responsible for obtaining, prior to submission of the Entry, any and all releases and consents necessary to permit the use and exhibition of the Entry by Sponsor in the manner set forth in these Official Rules, including, without limitation, name and likeness permissions from any person who appears in or is included in the Entry. Sponsor reserves the right to request proof of these permissions in a form acceptable to Sponsor from any entrant at any time. Failure to provide such proof may, if requested, render Entry null and void. By submitting an Entry, each entrant warrants and represents that he/she and any persons appearing or who are included in the Entry consent to the submission and use of the Entry in the Contest and to its use as otherwise set forth herein. Sponsor reserves the right, in its sole discretion, to verify any element of any Entry or related materials and to disqualify any entrant whose participation may subject the Contest, Sponsor, or Sponsor's advertisers, clients, or customers to controversy, negative publicity, scorn, or ridicule.

By submitting an Entry, each entrant agrees that the Entry conforms to these Official Rules and that Sponsor, in its sole discretion, may disqualify the Entry for any reason, including if it determines, in its sole discretion, that the Entry fails to conform to these Official Rules in any way or otherwise contains unacceptable content as determined by Sponsor, in its sole discretion.

By submitting an Entry, each entrant hereby grants permission for the Entry (or portions thereof) to be posted at <http://www.AllPeopleQuilt.com> and www.CityQuilter.com or other websites. Entrants agree that Released Parties (as defined below) are not responsible for any unauthorized use of Entries by third parties. Released Parties do not guarantee the posting of any Entry and reserve the right to remove any posted Entry at any time whatsoever and/or for any reason. Entrants agree that they will not use the Entry for any other purpose, including, without limitation, posting the Entry to any online social networks, without the express consent of Sponsor in each instance.

LIMIT: Five (5) Entries per person throughout the Contest Period. Multiple entries by the same person must be submitted as a separate Entry and must meet all requirements detailed herein.

ELIGIBILITY: This Contest is open to legal residents of the 50 United States, and the District of Columbia, 18 years of age or older, including professional and amateur quilters. Employees of Sponsor, The City Quilter, Metropolitan Transportation Authority, the New York Transit Museum and any other organizations affiliated with the sponsorship, fulfillment, administration, prize support, advertisement or promotion of the Contest and/or their respective parents, agents, affiliates, subsidiaries, and advertising and promotion agencies, and their immediate family members (regardless of where they reside) or household members, whether or not related, are not eligible to enter or win. "Immediate family members" shall mean spouses, parents, step-parents, children, step-children, siblings, step-siblings, and their respective spouses. "Household members" shall mean people who share the same residence at least three months a year.

JUDGING: There will be two (2) rounds of judging:

First Round: On or about September 13, 2013, a qualified panel of judges selected by Sponsor will judge all eligible Entries received based on the following criteria: adherence to Grand Central Terminal Centennial theme (50%), general appearance and design (40%), written explanation of interpretation of theme (10%). The thirty (30) Entries receiving the highest total scores will be deemed potential Finalists and advance to the Second Round. In the event of a tie, the Entry among the tied Entries having the highest score in the criterion of general appearance and design will advance to the Second Round. Sponsor reserves the right to select fewer than thirty (30) potential Finalists if, in its sole discretion, it does not receive a sufficient number of eligible and qualified Entries. Decisions of judges are final and binding in all respects.

Potential Finalists will be notified via email to confirm eligibility and compliance with the Official Rules and each potential Finalist will be required to send his/her Quilt by October 16, 2013 or an alternate potential Finalist may be notified. If notification is returned as undeliverable, Sponsor is unable to contact any potential Finalist or any potential Finalist is not in compliance with these Official Rules, or potential Finalist fails to send his/her Quilt for receipt by Sponsor by the specified date, such potential Finalist will be disqualified and, at Sponsor's discretion, an alternate Finalist may be notified. Each Finalist must attach two 4"-wide hanging sleeves on the back of the Quilt prior to submitting to Sponsor (one at the top of the quilt and one at the bottom). Finalists must send Quilts to Sponsor at American Patchwork & Quilting, Grand Central Terminal Quilt Challenge Contest, 1716 Locust St., LN-204, Des Moines, IA 50309-3023 for receipt by Sponsor by October 16, 2013. Finalists will be responsible for any and all costs involved in shipping Quilts (including any insurance, etc.). While in Sponsor's possession, each Quilt will be insured for \$2,500. Sponsor will be responsible for return shipping (including any insurance, etc.) of Quilts back to Finalists. By sending a Quilt to Sponsor, each Finalist agrees that the \$2,500 insured value will be the sole liability for Sponsor with respect to damage or loss of any Finalist Quilt.

By sending Quilt to Sponsor for the Second Round of judging, each Finalist agrees that Sponsor may retain possession of his/her Quilt for exhibition purposes for up to one (1) year following the date of winner notification.

Second Round: On or about October 21, 2013, a panel of qualified judges selected by Sponsor will judge the Finalist Quilts based on the following criteria: interpretation and expression of the Grand Central Terminal Centennial theme (50%), general appearance and design (25%) and workmanship (25%). The one (1) Finalist Quilt with the highest total score will be deemed the potential Grand Prize Winner. The Finalist Quilts with the second and third highest total scores will be deemed the potential First Prize Winner and potential Second Prize Winner, respectively. Finalists with the 4th to 12th highest total scores will be deemed potential Honorable Mention Winners (nine (9) total). In the event of a tie, the Finalist Quilt among the tied Finalist Quilts having the highest score in the criterion of interpretation and expression of the Grand Central Terminal Centennial theme will be deemed the applicable potential winner. Decisions of judges are final and binding in all respects.

WINNER NOTIFICATION: On or about November 9, 2013, potential winners will be notified via email, phone and/or mail and will be required to complete and return an Affidavit of Eligibility/Ownership, IRS W9 form, License of Work and Release of Liability/Publicity within ten (10) days of date of notification or an alternate winner may be notified at Sponsor's sole discretion. If such documents are not returned within the specified time period, prize or prize notification is returned as undeliverable, Sponsor is unable to contact a potential winner or a potential winner is not in compliance with these Official Rules, prize will be forfeited and, at Sponsor's discretion, an alternate winner may be notified.
